It is essential to attach all documents to your application.

The list of documents is not exhaustive and the Foundation reserves the right to ask you for any other document it deems necessary.

We make you aware that the assets of the 2nd pillar cannot be used for financing:

- Normal maintenance of a dwelling,
- Mortage interest,
- Taxes due on the advance payment,
- Notary fees
- Land register fees
- For a purchase of land without construction .

Purchase

- 1. This form, completed, dated and signed
- 2. Copy of the identity card or passport of the insured and the spouse or registered partner (LPart)
- 3. Copy of the signed notarial deed or sale agreement or draft
- 4. Copy of the mortage contratct with financial plan
- 5. Certification of the notary which mentions:
 - Adress and price of the property
 - Mariatal status
 - The type of residential property (individual ownership, co-ownership mentioning share of ownership, or joint ownership);
 - The amount paid will be used exclusively to finance the main residence in accordance with the Swiss law inforce, otherwise i twill be returned to Patrimonia Foundation
 - Commitment to provide us a copy of the final deed of sale
 - Bank informations including the IBAN number
 - For purchase in Switzerland, commitment to proceed of the registration of sales restrictions according to the LPP with the land register.

- 4. Copy of detailed quotations
- 5. Copy of the firm and definitive building permit
- 6. Certificate from the bank mentioning:
 - That the amount paid by the Patrimonia Foundation will only be used for work carried out in the property according to the announced estimate
 - Commitment to return the funds if the work does not take place
 - Bank details to make the payment

Mortgage amortization

- Copy of the identity document or passport of the insured and the spouse or registered partner (LPart) 2.
- Copy of the notarial deed of sale 3.
- 4. Certificate of residence less than one month old
